## Background

## Outline

## Content

- What does the Lecture call the “theme verse” of the entire book? What does it tell us about wisdom? How should we respond?
- Describe what wisdom is, according to the Lecture, in your own words. How is this demonstrated in the book of Proverbs? How does this apply?
- What kinds of topics does the wisdom in Proverbs address? Why is this significant?
- What does the Lecture say about choices? How is this related to Biblical wisdom? How should we apply this insight?
- What does the Lecture mean when it claims that Proverbs is “God-centered”? Do you agree? Why or why not? Why is it illegitimate to separate Proverbs from God? What difference does this make?
- According to the Lecture, what is the difference between the wise, the non-wise, and the fool? What lesson should we learn from this? How does it apply?
- Define a “Proverb” in your own words, based on what you learned from the Lecture. What does a successful proverb accomplish? Why is this useful? How should we respond?
- How is a proverb different from a promise? What difference does this make in the way we should read the book of Proverbs?
- Why does it take wisdom to apply Biblical wisdom? What does this practically look like? How can you cultivate this in your own life and ministry?
- Describe each of the three principles how to read Proverbs in your own words. How does each protect us from error? How can you put each into practice in your own reading?

## Themes

- Explain each of the theological themes in your own words. What does each tell us about the content, message and significance of Proverbs? What does each tell us about God and how we should relate to Him? How should each idea be applied in current life?

- What does it mean that the fear of the Lord is the beginning of wisdom? Why is that important? How does it apply?
- Describe the “Two Ways” in your own words? What are the characteristics of each way? Why are there only two ways, and not more possibilities? What is the destiny of each? Which is better? Why?
- How is Deuteronomistic Theology demonstrated in Proverbs? Why does this matter?
